- I. Babu Lal Patni, a Company Secretary in Practice, having FCS No: 2304 & COP No: 1321, have been appointed as a Sccrutinizer by the Board of Directors of THE BORMAH JAN TEA COMPANY (1936) LIMITED (the Company) at their Board Meeting held on 17<sup>th</sup> August, 2015 for the purpose of scrutinizing the e-voting process(remote e-voting) and voting by use of ballot at the venue of 78<sup>th</sup> Annual General Meeting(AGM) under the provisions of Section 108 of the Companies Act, 2013 (the Act) read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended (Rules) on the Resolutions contained in the Notice to the AGM of the Equity Shareholders of the Company, held on 29<sup>th</sup> September, 2015 at Registered Office of the Company at "McLeod House", 3, Netaji Subhas Road, Kolkata-700 001.
